





INVITATION to the EFJ, ECPMF and IPI

workshop on Investigative Journalism and Defamation Law

THESSALONIKI, 18th – 20th October 2016

The European Center for Press and Media Freedom (ECPMF), the European Federation of Journalists (EFJ) and the International Press Institute (IPI) invite journalists and unionists to a three days Workshop on Investigation Journalism and Defamation Law, to be held in Thessaloniki (Greece) from October 18th to October 20th.

On the first two days, trainers and contributors from Greece and other European countries will work together with participants to describe the working environment for investigative journalists in Greece, and identify challenges and possible opportunities for them to develop their work. They will also present financial tools and funding models for investigative journalism, as well as digital tools to be used in order to protect data and communications while working as independent journalist. Covering refugees, as a demanding field for journalists with investigative skills in Greece and throughout Europe, will also be in the workshop's agenda. On Day 3, participants will focus on the Greek legislative framework regarding defamation, to compare the situation to this of other European countries. Trainers will present best practices for journalists to face such legislative challenges.

The workshop will be facilitated with the support of the local EFJ affiliate, the **Journalists' Union of Macedonia and Thrace Daily Newspapers** (ESIEMTH). All the works will be held in the Union's premises (Adress: 5, Stratigou Kallari, 54622 Thessaloniki). Working languages are **Greek and English** (interpretation will be provided).

There are 30 places available, and traveling and accommodation will be covered by the organisers for those who will have to travel to Thessaloniki (up to 20 participants).
